09.30-09.35 Welcome and introduction by Tony O’Riordan, *moderator: Chairperson AAE Insurance Committee*

09.35-10.30 **Experiences of performing the first ORSA**

Speakers: Clemens Frey, chairperson AAE Solvency II Non-Life working group

Elsa Renouf, Chairperson ERM Committee Institut des Actuaire (France)

Clemens will speak about the ORSA process in general, including the objectives, which parties are involved and the technical difficulties associated with the ORSA process. He will also speak on the roles in the process, particularly the roles of risk management and actuarial functions. Finally, he will cover the experience emerging from a few years of ORSA practice. Has ORSA been an eye-opener, and what is still needed to make it more value-adding for (re-)insurance companies?

Elsa will focus on how the ORSA is used to affect the perspective of the organisation on an ongoing basis. She will discuss the potential of the ORSA to produce an outcome that can be used to challenge the organisation’s view of itself and its strategies and policies. Elsa will also touch on the governance of the ORSA process and the involvement of Boards in designing and approving scenarios.

10.30-11.00 **EIOPA’s view of ORSA to date and challenges for the future**

Speaker: Dr. Manuela Zweimuller, Head of the Policy Department EIOPA, responsible for EIOPA’s regulatory and policy tasks in insurance and pensions.

Manuela will address the regulator experience of the ORSA papers which it has received, including statistics, benchmarking analysis and areas where practice has diverged from expectations. She will also cover EIOPA’s view of the future with ORSA and how it expects the practices and content to evolve. The presentation will include EIOPA’s expectation of possible learnings for companies from the ORSA process.

11.00-11.30 **AAE’s standard on ORSA – what does it contain and how is it expected to play a role?**

Speaker: David Hare, chairperson AAE ESAP3 Task Force

David will speak about the development of ESAP3 on *Actuarial practice in relation to the ORSA process under Solvency II*, which was issued by the AAE on 2 August 2017. He will explain the principles followed in deciding what to include in the standard and what to leave out, and discuss some of the key decisions taken in its development. David will finish by giving a flavor of the impact it is hoped the standard will have, both for actuaries and for other professionals involved in the ORSA process.
