- some problems with sound, speakers went on mute several times and/or were disconnected

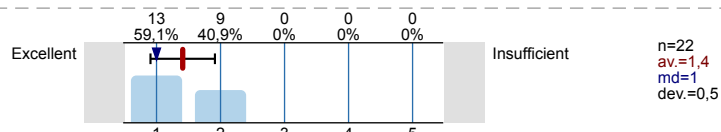
