 EIOPA's consultation on mass-lapse reinsurance and reinsurance termination clauses to enhance guidance on risk mitigation techniques (Solvency II)

- EIOPA Consultation on the proposal for RTS on management of sustainability risks including sustainability risk plans (SII) - deadline 26 February 2025
- EIOPA Consultation on a report on biodiversity risk management by insurers (SII) - deadline 26 February 2025
- EIOPA Consultation on revised guidelines on undertaking-specific parameters (SII) - deadline 26 February 2025
- EIOPA Consultation on revised guidelines on market and counterparty risk exposures (SII) deadline 26 February 2025
