Actuarial Association of Europe elects new Chairperson

Brussels, 26 September 2025

*The Actuarial Association of Europe (“AAE”) announced today that **Matthias Pillaudin** has been elected as the new Chairperson of the AAE ending October 2026.*



Matthias, a full member (Actuaire IA qualifié et certifié) of Institut des Actuaire (France), is currently Head of Actuarial department in life insurance at CNP Assurances. After being member of the AAE insurance Committee, he has served on the AAE Board of Directors since 2020, where he acted as Honorary Treasurer until 2024, in addition to his role as AAE Board member.

Matthias Pillaudin said: “It is a privilege to serve as Chairperson of the AAE and to represent European Actuaries at such a pivotal time. I am deeply grateful to my predecessors, whose dedication and leadership have laid a strong foundation for the work ahead. I also sincerely thank the member associations for the trust they have placed in me — this confidence is both humbling and motivating. Guided by continuity, our foremost objective is to confront the major challenges of a rapidly evolving world while embracing the opportunities to advance the actuarial profession in all its dimensions. During today’s General Assembly, **Malcolm Kemp** (UK) was elected as Vice-Chairperson until October 2026. Malcolm has served as a Board member since 2023.

Lutz Wilhelmy’s (Switzerland) term as Immediate Past Chairperson has ended as well as Frank Schiller’s (Germany) term as AAE Board member.

Susanna Adelhardt (Germany) and **Christophe Heck** (Switzerland) were elected as AAE Board member for a term ending in October 2028.

Gábor Hanák (Hungary), **Karin Hirhager** (Austria), **Raffaello Marcelloni** (Italy) and **Luis Saez De Jauregui** (Spain) were elected as members of the AAE Nominations Panel succeeding José Mendinhos (Portugal), Piotr Szlenk (Poland), Salvatore Forte (Italy) and Romain Durand (France).
